8. Pay Increases to Adjust to Market Forces

ED Decarreau noted that recent hiring processes led us to understand that our pay is low compared to the market and we are having a difficult time attracting skilled workers. In order to adjust some workers, we need to adjust those who are in similarly skilled positions to be fair, and to assure we do not lose staff. Commissioner Arnell asked if we had made sure to adjust to make sure we did not introduce gender inequality. ED Decarreau stated that we would conduct a review to be sure.

9. Review HUD – HCV

ED Decarreau review the attached presentation as an introduction to the Housing Choice Voucher Program. Note was made that we are only converting 15% of the vouchers we offer into actual rentals. This has several causes, including the lack of affordable housing units available in the area, the condition of those properties, and a lack of family housing (more than 2 bedrooms) available.

The Board agreed to invite City staff into discuss the housing issues and how we might work together to solve the issues.

ED Decarreau will set up a meeting.
